7. Minimum daily hours of in-vehicle instructions are two for weekdays and four for weekend days.
8. Minimum of 50 miles B-T-W instructions in vehicle students operating the vehicle.
9. The vehicle is equipped with seatbelts, rear view mirrors, roof top and rear display signs.
10. The vehicle has met all safety requirements and inspected by the DMV.
11. The vehicle has been cleaned and sanitized for each participant.
12. Participant will be picked up and dropped off when arranged to do so.
